#### Complementary medicine advertisers: new applications for approval of medicines advertising

From 19 Nov 2019, all new applications for approval of medicines advertising in any specified media (broadcast, print, cinema or public display) should be lodged with [Consumer Healthcare Products Australia](#) (CHP Australia), which was previously known as the Australian Self Medication Industry. Complementary Healthcare Council of Australia (CHC) is not accepting any new applications for advertising pre-approvals. Applications sent to CHC or TGA will be forwarded to CHP Australia. Applications that were received by CHC before 14 Nov will still be processed and decided by CHC, with final decisions for all these applications to be made by 27 Jan 2020.
