# Changes to Nappy Rash products Formation of the Naturopathic Council of Australia

## **Changes to Nappy Rash products**

From 1 January 2020, <u>some nappy rash products will become exempt</u> from regulation under the Therapeutic Goods Act, from any requirement to be entered on the ARTG and from any requirement to be made under GMP.

This regulatory change will apply to listed medicines and Class I medical devices which are indicated for nappy rash symptoms, **via a barrier effect only**.

The exemption will **not apply** to nappy rash preparations:

- That are also indicated for other skin conditions, such as eczema, psoriasis and dermatitis,
- Where relief of nappy rash symptoms are provided by another mechanism, and
- Those nappy rash preparations that are registered medicines.

#### **Background**

The history of this changes arises from MMDR recommendations to review the <u>regulation of low risk</u> <u>products</u>. Consequent to consultations in 2017, the TGA announced in December 2018 the regulatory changes to nappy rash products.

#### How will exempt products be regulated?

To exempt devices, a declaration will be made under section 41BD(3).

For listed medicines, eligible nappy rash products will become exempt from the requirement to be entered into the Register (part 3-2 of the Act), and exempt from having to be made in accordance with GMP standards (part 3-3). However as these products will still fall under the oversight of the TGA, they will still be subject to <u>controls and standards</u> of listed medicines, such as acceptable presentation and safe for its intended purpose.
